The changes include: a member of the public body can participate in a meeting via tele or video conference; at the discretion of the chair a member of the public who is the subject of an action item on the agenda may attend and participate in the public meeting by means of tele or video conference; updates the OML to allow for training regarding legal obligations of the OML without limitation, conducted by the Office of the Attorney General or the Commission on Ethics when the training is attended by 1 or more members of the public body, however the language clarifies that the training cannot be used to deliberate to a decision on any matter over which the public body has jurisdiction, supervision, control or advisory power over; expands the definition of when the OML would apply, including any public body as defined that is supported by tax revenue, or which advises and makes recommendations to any entity which expends or disburses or is supported in whole in part by tax revenue, including but not limited to, any board, commission, committee, subcommittee or other subsidiary as defined in NRS. This includes a body that is created by, a resolution, or other formal designation by such a body created by a statute of this State or an ordinance by local government, a resolution or an action by the governing body of a political subdivision of this State, a subcommittee or working group consisting of at least 2 persons who are appointed by a public body as described in this bill, a majority of membership of the subcommittee or working group are members or staff members of the public body that appointed the subcommittee, the subcommittee or working group is authorized to make a recommendation to the public body for the public body to take any action. Updates supporting material to apply to written records, audio recordings, video recordings, photographs and digital data. Mandates that the posted agenda must be approved by a quorom of the meeting, if not the chair must adjourn the meeting. A new provision regarding "closed" sessions, if a meeting is closed to consider character, alleged misconduct, or professional competence of a person, the name of the person whose character, alleged misconduct or professional competence must be listed on the agenda item announcing the closed session. At the discretion of the chair only, agenda items may be taken out of order. At the discretion of the chair the public body may combine two or more agenda items for consideration. This bill would require that any agenda item being considered for removal, must have the agenda in whole approved by the public body and then a subsequent vote must take place to remove the item. Mandates, that if a guorum of members receive supporting materials, as defined, a member of the public is allowed at no cost to have one copy of the supporting material at the time the information is provided to at least a quorum of the members of the public body. Requires counties of populations greater than 45k to post materials, including agenda and supporting materials on their website for the public to access. Requires that the public body shall approve minutes of a meeting within 45 days after the meeting or whenever the next meeting takes place, whichever
