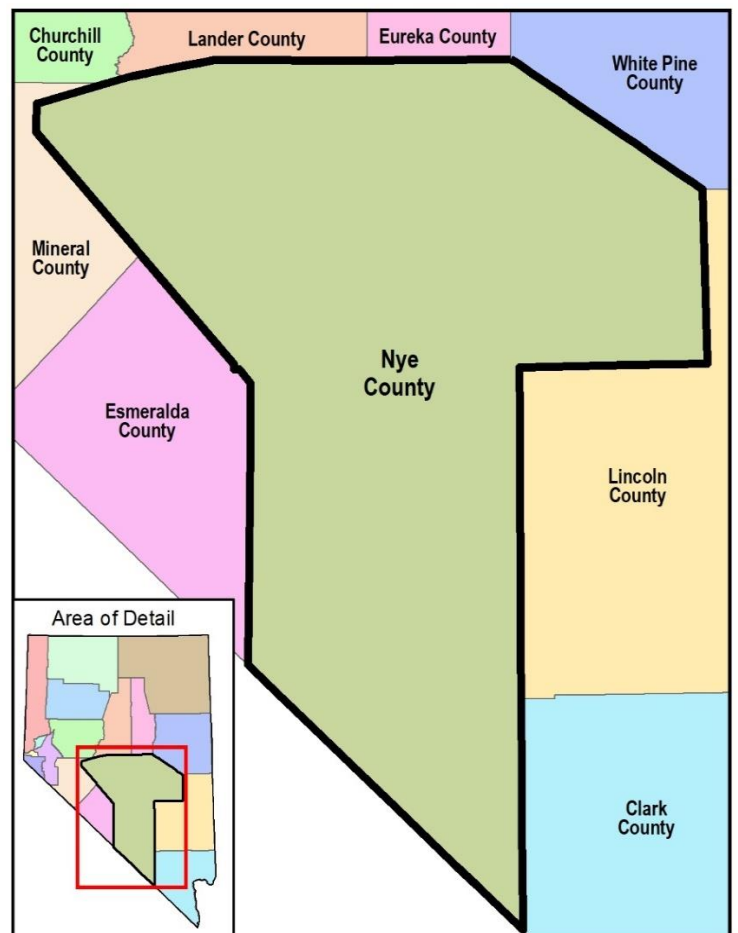

## Notes

County populations are from vintage 2015 data provided by the Nevada State Demographer.

**1**Data reflects the causes of deaths that occurred between 2013 and 2015. Only Nevada residents are included in the data.

**2**Racial/Ethnic populations for each County were obtained from the Nevada State Demographer; vintage 2015.

**3**Income below poverty level (PL) was obtained from U.S. Census Bureau, 2011-2015 5-Year American Community Survey, Table DP03 – Selected Economic Characteristics

**4**Uninsured reflects individuals without insurance covered. Data was obtained from U.S. Census Bureau, 2011-2015 5-Year American Community Survey, Table S2701 – Health Insurance Coverage Status.

**5**Cancer incidence is reflective of the number of reportable cancers diagnosed in 2013 that were reported to the Nevada Central Cancer Registry.

**6**General Health indicators are collected from the Behavioral Risk Factor Surveillance System (BRFSS). All indicators reflect responses from 2011-2015, except mammogram, Pap test, and PSA test which reflect responses from 2012 and 2014 only. \*Indicators with too few responses were suppressed due to reliability.

**7**“Currently Enrolled” is reflective of all individuals who were enrolled in July of 2017 within Medicaid, Supplemental Nutrition Assistance Program (SNAP), and/or Temporary Assistance for Needy Families (TANF) (Data as of July, 2017).

**8**“Newly Eligible” is reflective of individuals who are eligible because of the Affordable Care Act (ACA). These individuals fall into one of three categories: Parent/Caretaker, Childless Adult, and CHAP (eligible under ACA expansion).

**9**Nevada residents only are included in the data. Data provided from Nevada Vitals Statistics.

**10**Data reflects the births that occurred between 2011 and 2015.

**11**Low-Birthweight data reflects the births that occurred between 2011 and 2015.

**12**Infant mortality data reflects the deaths that occurred between 2011 and 2015.

**13**Teen birth rate data reflects the births that occurred in 2015.

**14**Persons Living with HIV indicate any person regardless of HIV staging, including HIV stage 3 (AIDS), living in Nevada at the end of 2015.

**15**Sexually transmitted diseases includes all individuals reported to have chlamydia, gonorrhea, primary and secondary syphilis, and early latent syphilis in MMWR Year 2015.

**16**Drug overdose deaths occurred between 2013 and 2015. This indicator excludes alcohol and tobacco related events.

**17**Emergency room visits and inpatient hospitalizations that occurred between 2013 and 2015.
