# CREATION OF NEVADA'S COUNTIES

On November 25, 1861 the first Nevada Territorial Legislature established Nevada's first nine counties, Churchill, Douglas, Esmeralda, Humboldt, Lyon, Ormsby, Storey, Washoe and Lake. Lake County was renamed Roop County in 1862 and was consolidated with Washoe County in 1889.

Lander and Nye were organized later, bringing the total number of Nevada counties to 11 on the eve of statehood in 1864. Four more counties were organized during the first 10 years of Nevada's statehood: Elko, Eureka, Lincoln and White Pine. Thirty years then passed before Nevada's final three counties Clark, Mineral and Pershing were created. Ormsby County and Carson City were consolidated in 1969 and retained the name of Carson City.

In 1987 the Legislature created Bullfrog County carving out a portion of southern Nye County to enhance the state's ability to receive 'Payments Equal To Taxes' funds under the provisions of the Nuclear Waste Policy Act. Nye County challenged the legislation and in 1988 it was deemed unconstitutional. In 1989, the Legislature dissolved Bullfrog County maintaining Nevada's counties at a total of 17.
