A YEAR IN REVIEW - 2025

Nevada's Counties – Navigating Today, for Tomorrow's Excellence

The Nevada Association of Counties, representing all of Nevada's Seventeen Counties, worked tirelessly on many fronts this year, including navigating a busy legislative session, a special session of the Nevada legislature to accommodate *unfinished* business from the regular session in November, as well as another successful annual conference which was held for the first time in 10 years, in Clark County.

Our theme this year reflected Counties day in and day out efforts to provide services to our residents, as well as plan for tomorrow.

At this year's Annual Conference, we heard from a sitting Governor from the first time in our Association's history. Governor Lombardo touched on how critical it is to have a dialogue with local leaders, who are the ones that get work done, capturing the tone of our conference theme. Highlighting how Counties work to excel for the future while navigating the challenges of today.

NACO was there every step of the way this year, navigating a challenging legislative session. Where we modernized local elected official pay, which saw a raise for our elected officials for the first time in nearly a decade. We provided tools to our local elected officials to navigate community blight, provide for cost recovery for renewable energy projects on federal lands, continued funding for local public health and softened the fiscal impact of the 48-hour pre-trial release mandate that was passed by the Legislature in 2021.

We passed critical bills, nuanced new oversight of county authority as the state split up the Department of Health and Human Services, which saw the creation of the Nevada Health Authority. We worked to mitigate county fiscal impacts and mandates to county operations which often have more detrimental effects than fiscal ones.

NACO continues to support and provide resources for our 100% county membership, you will see additional county workshops this year, including a symposium on *Rural Child Welfare*, as we host four virtual symposiums with the Division of Child and Family Services. These symposiums will cover a litany of topics, with the goal of understanding budgets, operations and increasing coordination with local leaders.

Our work on the full funding of Payment in Lieu of Taxes (PILT) and Secure Rural Schools (SRS) funding continues, along with the flurry of Federal rules that continue to come from the federal government. NACO, with the work of our individual county partners, have been able to beat back rules that would have limited the local government voice on rulemaking. No state is more heavily impacted by that limitation given that Nevada is comprised of nearly 86% Federal Land ownership. NACO has stood at the ready to serve counties and we will continue to do so in the future on these issues that have an acute impact on our county membership.

NACO staff will continue to visit counties to share NACO programs and advocacy. NACO is proud of the collaboration, leadership, and accomplishments of our member counties this year. We are looking forward to rolling out dynamic cost saving and efficient administration programs that benefit our counties and provide overall good governance at the local level.

NACO LEADERSHIP

The NACO Board of Directors is comprised of at least one Commissioner from each of our member Counties plus the Presidents of our Affiliate Member organizations. Clark and Washoe Counties may elect to have a second member serve on NACO's Executive Committee and an additional representative may be appointed from the counties of a current officer as well as of those Commissioners representing Nevada on the National Association of Counties Board and the Western Interstate Region Board.

LEGISLATIVE COUNSEL BUREAU

In March of 1945, the Nevada Legislature recognized a need for more information and assistance in order to deal with increasingly complex tasks as described in the preamble to the bill creating the Legislative Counsel Bureau:

At each biennial session of the legislature, that body is confronted by requests for legislation expanding and changing the functions of and increasing the appropriations of numerous offices, departments, institutions, and agencies of the state government; and . . . notwithstanding the information provided by the messages and budgets of the governor and the reports of public officers, it is impossible for the legislature or its committees to secure sufficient information to act advisedly on such requests in the time limited for its sessions.

In 1963, the Nevada Legislature reorganized the Legislative Counsel Bureau, giving it structure and responsibilities similar to those it has today. One part of this change was the incorporation of the Statute Revision Commission into the Legislative Counsel Bureau as the Legal Division. The 1963 legislation also added a Fiscal and Auditing Division and a Research Division.
