#### **UNADOPTED MINTUES**

**ATTENDANCE:** President Higbee, President Elect Giomi, Past President Kirkpatrick, Douglas County Commissioner Gardner, Elko County Commissioner Andreozzi, Humboldt County Commissioner Tipton, Lincoln County Commissioner Reese, Lyon County Commissioner Henderson, Nye County Commissioner Boskovich, Storey County Commissioner Carmona, Washoe County Commissioner Herman, White Pine County Commissioner Carson, Fiscal Officer Kalt and NACO Staff (Vinson Guthreau, Jennifer Berthiaume, Jacob Brinkerhoff, Amy Hyne Sutherland, and Amanda Berg)

The meeting was called to order at 9:33 a.m.

- 1. Public Comment. None was given.
- 2. **Approval of Agenda**. The agenda was approved as presented on a motion by Commissioner Gardner with second by Commissioner Andreozzi
- 3. NACO President's Report. President Elect Giomi informed the Board that President Higbee was attending a meeting of the National Wild Horse and Burro Advisory Board, and he would join the meeting if he was able. He reminded the Board that the January meeting will take place on the 26<sup>th</sup>, where the 2024 Officers would be invested and encouraged all those able to attend in person. President Elect Giomi then discussed issues with a specific foam material used to combat carbon-based fires and encouraged the Board to keep an eye on the situation as the replacement retardant is not currently being produced in quantities to make it widely available. He concluded his remarks by noting that there may be an opportunity to go before the Interim Finance Committee for dollars to assist with hazardous material disposal costs for stock of the current retardant.
- 4. **NACO Executive Director's Report**. Vinson informed the Board that the National Association of Counties (NACo) is also monitoring the situation with the material discussed by President Elect Giomi and that he would gather and distribute materials from them following a final decision by the Emergency Response Commission. He thanked the Board for a successful year, noting that 2023 was a Legislative year that brings additional challenges. He reminded the Board of the upcoming NACo Legislative Conference in February directing the Boards attention to the link included in the agenda packet. He informed the Board that materials for Nevada specific events during the conference including meetings with the State's Federal Representatives would be distributed to those registered for the event. Vinson concluded his remarks by wishing the Board a happy holiday season.

- 5. **Approval of Minutes of the November 18, 2022, NACO Board of Directors Meeting**. The minutes were approved as written on a motion by Commissioner Andreozzi with second by Commissioner Herman.
- 6. Presentation and Discussion Regarding the Economic Recovery Transportation Electrification Plan (ERTEP), Dustin Newsom, Senior Project Manager, Integrated Energy Services, NV Energy. Government Relations Advisor, Chloe Chism thanked the Board for the opportunity to present to the group and introduced Mr. Newsom. Mr. Newsom then gave an overview of the program to expand electric vehicle charging locations across the NV Energy service area. He explained what makes a site appropriate or ideal and how SB448 provides funding to assist in alleviating the financial burden to public agencies. Mr. Newsom discussed the differences between for profit charging sites and those designated as community charging centers, giving an overview of the different ownership models included within the ERTEP. Vinson requested examples of what a third party is vs. a Public Agency, and it was clarified that shopping malls and other private industry locations would fall under the 3<sup>rd</sup> party designation while facilities such as Community Centers, Senior Centers and other similar locations owned by local governments would fall under the Public Agency category. Commissioner Gardner inquired as to if there was the ability to mitigate lost revenue to the counties from the reduction of fuel taxes and Mr. Newsom stated that under the Customer Owned model there is the ability to allow for recoupment of costs by setting charging fees, but that under the utility owned model there is no way to bridge that gap. President Elect Giomi informed the Board that Carson City passed an ordinance to address the issue with a set rate and that he would share that information. Mr. Newsom clarified that the charging station must reside on publicly owned land to take advantage of the ownership share model within the program. The Board also inquired as to issues with capacity in rural areas and whether the program considered areas not served by NV Energy. It was clarified that capacity investigations are conducted prior to identification of viable site locations and that under the current legislation areas outside of NV Energy service are not eligible for the program. Revenue loss was a continued discussion and President Elect Giomi reminded the Board that NV Energy was not responsible for that issue. Following additional review of the legislation, Jennifer clarified that NV Energy is the only utility that can access the funding due to the language of the Bill. The item was concluded by Commissioner Carmona who informed the Board that a town hall with NDOT that would be taking place in Storey County was expected to include discussion on taxation of electric vehicles to make up for lost revenue to both the State and the local taxing jurisdictions.
- 7. **Approval of NACO Resolution 23-04 Recognizing January 2024 as National Radon Action Month**. President Elect Giomi read the resolution into the record, and it was approved on a motion by Commissioner Andreozzi with second by Commissioner Gardner.
- 8. **Preliminary Presentation and Discussion of NACO Federal Priorities for 2024**. Jennifer directed the Boards attention to the document included in the agenda packet. She reminded the Board that it is a document produced annually and that the House of Representatives would be in session during the upcoming NACo Legislative Conference. Jennifer then outlined the changes and updates made to the priorities, noting that they were highlighted within the document. She explained that no action was needed, but that staff is requesting Board feedback and is welcome to questions or comments. President Elect Giomi concluded the item by requesting that any comments, additions, or questions be communicated to staff

by January 15<sup>th</sup> so the document could be updated before the January Board meeting where the Board will take action to approve the Associations 2024 Federal Priorities.

- 9. Annual Update from NACO Investment Advisor, Moreton Asset Management, LLC, Dan Rusk, Portfolio Manager. Mr. Rusk began his presentation by discussing inflation, noting that it has recently come down with prices rising less rapidly than earlier in the year. He discussed recent decisions by the Federal Reserve to begin lowering interest rates which are expected to be reduced three times in 2024, to begin in March with quarterly reductions expected to total 1.5% as determined by market actuators. Mr. Rusk informed the Board that the Association's portfolio is currently experiencing a 4% yield with some unrealized gains, noting that year-to-date the net income in the portfolio was approximately \$20,000, which was almost as much as the two prior years combined. He discussed current investments in bonds which are locked with interest rates that will not be affected by the expected cuts. Vinson informed the Board that the service given by Moreton is excellent and reminded them that the annual update is included within the Association's service agreement. Fiscal Officer Kalt concluded the item by informing the Board that the current investment mix is in compliance with the Board's adopted policy and that no adjustments were recommended by the Account Advisor.
- 10. Final Discussion and Approval of NACO 2024 Budget. Vinson reminded the Board that the draft budget was brought before the Board in November for initial discussion and review. He directed the Boards attention to the documents included in the agenda packet and noted that per Commissioner Andreozzi's request, a column for the 2023 approved budget was added for comparison purposes. While no direct feedback was received from Board members, Vinson discussed comments received from Fiscal Officer Kalt, including the overview of additional cash management processes as previously directed by the Board, which have resulted in an increased percentage yield for the Association. Commissioner Andreozzi thanked Vinson for the additional comparison column and requested that it be made a yearly practice moving forward. President Elect Giomi suggested making it three running years going forward to echo more accurately what the counties include in their own budget development processes. Vinson informed the Board that there was an error in the motion verbiage included in the agenda packet and requested that the motion include his suggested change of verbiage to include \$763,238 in revenues with expenses totaling \$760,872. Fiscal Officer Kalt thanked staff for being good stewards of the Association's resources and President Elect Giomi added thanks to Mr. Kalt for volunteering his time and expertise as the NACO Fiscal Officer. The 2024 NACO Budget was approved as suggested on a motion by Commissioner Andreozzi with second by Commissioner Herman.
- 11. Updates from NACO Public Health Coordinator, Including Presentation and Discussion of Year-End Summary of Activities. Amy directed the Board's attention to the document included in the agenda packet. She gave an overview of the work conducted on behalf of all the counties, but reminded the Board that support is available for singular issues within the counties. She reminded the Board that the NEAP assessments are ongoing and will provide baseline data to the counties that will help support future public health decisions. Amy discussed the support provided to the NACO Government Affairs staff during the Legislative Session, reminding the Board that she is unable to testify due to the position being grant funded. She concluded her remarks by thanking the Board for the opportunity to provide service to the counties and that she looks forward to continuing to provide support going forward. Commissioner Andreozzi inquired as to any work being done to address the increase in suicides during and following the pandemic. Commissioner Gardner noted that Douglas County is seeing an increase in those actions among their older

populations. Amy noted that increased suicide is a major issue among all demographics and that peer and telehealth support is available.

#### 12. Update and Possible Action. Regarding Public Lands and Natural Resources Issues Affecting Counties Including:

- a. **Updates from the NACO Public Lands and Natural Resources Subcommittee.** Jacob reminded the Board that the Subcommittee had met the previous day, and that discussion included the Climate Change Priority Action Plan being developed by NDEP, and that they had requested input from NACO, noting that if members shared their thoughts on priorities with him, he would provide a collated list to the Division. He informed the Board that discussions had also taken place on the BLM's inventory of lands with wilderness characteristics and that while a request had been made for them to share that information, no decisions had been made or actions taken at the time, but that the inventory would be included in future Resource Management Plans. The Farm Bill was also discussed, and President Higbee had encouraged a NACO resolution supporting the inclusion of woody biomass in farm bill definitions, NACO had also signed on to a letter requesting additional funding for the Wild Horse and Burro program.
- b. Presentation and discussion of the "Western Alliance Smart from the Start Alternative" for BLM Solar PEIS. lacob discussed work conducted on behalf of the Association as a Cooperating Agency, noting that communication and close work was done with the counties natural resource staff. He informed the Board that comments were submitted that were slightly more restrictive than any of the BLM's published alternatives and directed the Board's attention to the document included in the agenda packet. He gave an overview of the document, including the specific definition of disturbed lands and requested that the Board approve the comments submitted as their official position. President Elect Giomi inquired as if the submitted document left room for exploration and Jacob stated that there is enough land available to meet the administration's renewable energy goals by more than double. Commissioner Andreozzi inquired about waste and abandonment and Jacob noted that those items were addressed as well, however the specific item at hand was only regarding citing of solar fields. He also informed the Board that he is looking to provide a spring workshop on the issue of solar energy devellopment. Commissioner Carson suggested that counties add language specific to Smart from the Start within their updates to county land use plans, as White Pine County had done. The submitted comments were ratified on a motion by Commissioner Andreozzi with second by Commissioner Carson.
- c. **Presentation and Discussion of Year-End Summary of Activities from the NACO Public Lands and Natural Resources Subcommittee**. Jacob directed the Boards attention to the documents included in the agenda packet and drew specific attention to the comments submitted to various agencies on many issues affecting counties. President Elect Giomi thanked Jacob for his work, noting that NACO is looked to as an authority on natural resources issues because of the expertise of both staff and Commissioners across the State.
- 13. Updates from Members of the National Association of Counties Board, Western Interstate Region Board, and Individual Counties. Past President Kirkpatrick reflected on issues with the housing committee and President Higbee discussed the upcoming ARPA ruling from Treasury and continued work on the Farm Bill. Commissioner Tipton informed the Board that the WIR meeting for December had been canceled. Commissioners also gave updates on activities within their respective counties.

14. **Public Comment**. Holly Gatske from the University of Nevada Reno, thanked the Board for their support of Radon Action Month, noting that testing kits would be available at Extension offices across the state and that information on mitigation is also available. Ms. Gatske also informed the Board that research is being conducted by the University on components of photovoltaic agriculture to address impacts from solar fields.

The meeting was adjourned at 11:21 a.m.

## Nevada Association of Counties (NACO) Federal Priorities

## Public Health & Community Resiliency

Nevada's counties continue to provide the local social safety net and the many community services that Nevadans depend on, while supporting our communities as they focus on growing the economy and supporting our citizens on a pathway to resiliency.

**Continued Support for Public Health:** While unprecedented federal funding and aid to counties has occurred in recent years, it has served to highlight the need for additional long-term support for our country's public health system. In Nevada, public health is provided through a partnership between health districts, counties, and the State. During Nevada's response to a historic public health emergency, we saw that the lack of sustained resources for health districts, emergency responders and county hospitals complicated those efforts. As a result, in partnership with the State, Nevada's counties will focus on working with the federal delegation to support increased funding for public health so that we can be better prepared for any future public health crisis. This includes support for Federal scholarships, loan repayment programs, and direct support for training of all public health professionals in building the state's public health workforce. As Nevada's counties explore ways to stand up additional public health services, we look to the federal delegation to support these efforts with direct funding that supports these local programs. NACO supports a federal effort for a comprehensive state and local analysis of the Public Health System and current and effective local and regionally driven policy recommendations.

**Direct Assistance to Counties for Ongoing Mental Health Response:** NACO thanks our Nevada Congressional delegation for supporting the initial CARES ACT funding, a vital first step in getting relief to our counties. Also, counties applaud the passage of the American Rescue Plan Act (ARPA) which provided \$1.04 billion in direct, flexible funding to local governments, to mitigate impacts from the pandemic and support the ongoing response to COVID-19. As a direct result of the passage of ARPA, counties have stood up programs to assist small businesses, local nonprofits, and recover lost revenue, along with housing, nutrition and mental health programs with a focus on children's behavioral health.

With 75% of the U.S. population reliant on county-based behavioral health services, the National Association of Counties (NACo) launched a <u>Commission on Mental Health and Wellbeing</u>. The Commission aims to bring county leaders from across the country together to address the mounting mental health crisis from the local government perspective while building and supporting the mental health workforce, and enhancing local crisis response systems.

## **Health & Human Services**

Protect the Federal-State-Local Partnership for Medicaid: NACO supports maintaining the federal-state-local structure for financing and delivering Medicaid services while maximizing or enhancing flexibility to support local systems of care. Counties have made the most of Medicaid's flexibility and have supported health systems that serve a disproportionate share of low-income populations, including the homeless, and those cycling in and out of county jails. Nevada counties are opposed to any measures that would further shift Medicaid costs to counties. In Nevada, counties already provide an important part of Nevada's non-federal Medicaid contribution, and as Nevada's Medicaid caseloads continue to grow, counties are concerned about any proposal that increases State or local responsibility for Medicaid funding. If Medicaid costs or costs for uncompensated care for indigent individuals were increased, counties in Nevada, who have limited ability to raise revenues, would be hard-pressed to meet new fiscal responsibilities. Medicaid funding also impacts county hospitals - without sustained funding, some county hospitals may be forced to shutter their doors. Counties do support efforts to improve the efficiency, flexibility and effectiveness of policies and operations. NACO supports the strengthening of the intergovernmental partnership envisioned in the Medicaid statute and the provision that requires the Federal Medical Assistance Percentage (FMAP) to be passed through to counties contributing to the non-federal share.

## **Justice and Public Safety**

**Medicaid Inmate Exclusion Policy (MIEP):** While the state of Nevada passed a state-based solution to the MIEP, NACO continues to support a federal solution to the policy that upon detention (*not conviction*) inmates are no longer eligible for Federal health benefits. The current federal policy denies federal health benefits to individuals who are pending disposition, and still presumed innocent under the U.S. Constitution. Instead, NACO supports access to federal health benefits for non-convicted individuals as it would allow for improved coordination of care, and also decrease short-term costs to local taxpayers and long-term costs to the federal government.

The National Association of Counties partnered with the National Sheriffs Association taskforce and issued a detailed <u>report</u>, which includes recommendations on removing the MIEP. The report, provides information on steps federal, state, and local policymakers can address on inmate healthcare, addressing bail and various other criminal justice reforms. NACO urges Congress to amend the MIEP, allowing pre-trial detainees to access Medicaid services while awaiting trial.

**Mental Health and Jails:** County jails are not the appropriate place to treat individuals with mental illness, unfortunately, 64% of jail inmates in the United States have a behavioral health issue. In Nevada, our county jails are the largest provider of behavioral health services in the State. NACO supports sensible measures that promote and advance the overall safety of the public and the communities we serve. Within this context, we also support policies and approaches that would enhance the ability of counties to prevent and treat mental illness and substance use disorders, both in the community and within the context of the criminal justice system. For example, NACO encourages federal support for the NACO <u>Stepping Up</u> Initiative, a national initiative to reduce overincarceration of people with mental illnesses, that was launched in 2015 together with the CSG Justice Center and the APA Foundation.

NACO also supports programs and legislation that divert non-violent individuals struggling with mental illness and/or substance use disorders from jails and into treatment programs while protecting overall public safety. Two critical federal programs that counties rely on to provide services to our incarcerated populations and reduce recidivism are the Justice and Mental Health Collaboration Program (JMHCP) which offers grants to help in the preparation of comprehensive plans to implement collaborative programs that target qualified offenders and promote public safety and the Second Chance Act, which supports state and local government, and nonprofit organizations in their work to reduce recidivism and improve outcomes for people returning from state and federal prisons, local jails, and juvenile facilities.

## **Public Lands & Natural Resources**

Public Land Management and Funding County Services: As Nevada's Congressional Delegation is aware, Nevada has the largest percentage of federal lands of any state in the contiguous 48 at over 80% federal ownership. Some of our counties (Nye, Esmeralda, Lander, Lincoln, and White Pine) have over 90 percent of their acreage administered by the federal government. As a result, Nevada's counties find their local economies, fiscal condition, and quality of life are greatly influenced by federal land management decisions. For example, in many Nevada communities, resource-based industries that are tied to public lands are their lifeblood and public access for recreation is also a high priority. It is important to recognize the impacts of public land use on local economies and ways of life, as well as on demand for county services. For all Nevada counties, staying involved in federal land management planning and conservation efforts is critical. Counties provide road maintenance, emergency response, law enforcement and other mandated services on public lands and to public lands users. Counties also manage assets that require federal permits, leases, or easements. NACO supports the following: efforts to increase federal land managers' engagement with county governments; appropriate federal revenue sharing to support county services; and the transfer of select federal land to states or counties when feasible and where appropriate, based on consultation with or direct recommendation of the affected county. NACO thanks the Nevada delegation for their support of full funding of the Payment In Lieu of Taxes (PILT) and Secure Rural Schools (SRS) programs. These payments

to counties offset a portion of the losses in tax revenues that result from the federal land ownership within their jurisdictions. Because local governments are unable to collect property taxes on federal lands, Nevada's rural counties increasingly rely on these payments to balance their budgets and provide essential services. NACO supports comparable funding that allows counties to provide the above-mentioned essential services and remain solvent.

**Consultation on Planning and Rulemakings:** NACO is appreciative of the delegation's support on several significant land withdrawal proposals. NACO will request cooperating agency status on federal planning associated with the National Environmental Policy Act (NEPA) and engage in rulemaking efforts that affect Nevada's counties. Even where NACO is not a cooperating agency, consultation and coordination with counties is crucial. Whether it is a species listing, or a monument designation, counties take federal mandates to consult very seriously. NACO is a Cooperating Agency for the BLM's Greater Sage-grouse Land Use Plan Amendment Environmental Impact Statement, and the Western Solar Programmatic Environmental Impact State-wide Resource Management Plan (RMP) Update. NACO remains concerned about the *30x30 Initiative* proposed by the Biden Administration and provided input on the "*Conservation Atlas*".

**Renewable Energy:** While supporting diversification of energy production that brings economic activity to Nevada, NACO has also long held the position that public lands administered by the federal agencies should be managed for multiple uses. NACO is concerned with the significant increase of proposals which would narrow public land use solely to renewable energy infrastructure (particularly solar arrays) across significant acreages. Nevada's counties should be compensated for these use restrictions, as well as the services counties will be expected to provide as these projects are constructed. Tax abatements and exemptions extended to renewable energy companies result in county taxpayers subsidizing renewable energy projects. Renewable energy projects should contribute to their local economies with ongoing revenue streams so that the counties are able to provide the required support services during the life of these projects. County government should provide local input on renewable energy projects proposed on public lands and be remunerated for the permitting, infrastructure, safety and emergency services they will provide to these projects. NACO supports the Public Land Renewable Energy Development of Act of 2023 which would appropriate amounts collected for wind and or solar projects as bonus bids, rentals, fees, or other payments under a right-of-way, permit, or lease to the state (25%), the county (25%), Treasury (25%), and a Renewable Energy **Resource Conservation Fund (25%).** 

**Withdrawals of Public Lands:** The National Defense Authorization Act (NDAA) for Fiscal Year 2023 approved the Navy's proposed expansion of land ranges and modernization at the Naval Air Station Fallon (FRTC). The NDAA kept a "status quo" land withdrawal and did not include any expansion of the disposal boundary for the Air Force's Nellis Test and Training

Range (NTTR)NACO would like to thank the Nevada delegation for their efforts on the NDAA, and we appreciate the leadership and support from our Congressional Delegation on the Fallon withdrawal proposal. NACO looks forward to our continued partnership with the delegation to address county issues as the implementation of FRTC expansion and modernization moves forward. NACO remains concerned about the plans to expand NTTR, BLM initiating the process for additional land and mineral withdrawals in Northern Nevada, and NASA's land withdrawal in Railroad Valley. On all of these plans we strongly support engagement with the impacted local communities.

**Wild Horses and Burros:** Nevada has by far the largest population of wild horses and burros (WH&B) on public lands of any State. The Free-Roaming Wild Horses and Burros Act of 1971 requires the Bureau of Land Management (BLM) to maintain populations at an agency-determined appropriate management level (AML). Wild horse and burro populations continue to far exceed AMLs. Overpopulation remains a major impediment to effective land management and has created serious environmental concerns for wildlife, the ecology of Nevada's rangelands, and for the horses themselves. Wild horses suffer death from starvation or dehydration due to resource scarcity. NACO supports the \$153 million 2023 request from BLM for this program, but believes additional funding will be needed for this program to bring WH&Bs to AML and maintain them at that level.

NACO supports the <u>"The Path Forward"</u> proposal, which outlines a strategy of adoption, relocation, and fertility control that is both humane and promotes ecological balance. Achieving AML of Nevada's WHB populations as quickly and efficiently as possible is of everincreasing urgency to Nevada's rangeland ecosystems, and all of the socioeconomic activity that stems from having healthy rangelands across our state. NACO urges the Bureau of Land Management to follow the recommendations contained in their <u>2020 Report to Congress</u>. The recommendations therein reflect those in the Path Forward and BLM's recognition of the urgency of WHB management.

**Sage-Grouse:** Stakeholders across Nevada have engaged in significant collaborative conservation efforts and species management planning regarding both the Bi-State and Greater Sage-grouse. NACO has been a cooperating agency in both the Departments of Interior's and Agriculture's previous Greater Sage-grouse Land Use Plan Amendments. NACO believes the 2019 plans (*with 2021 E.I.S. clarification*) contain more accurate data and provide the flexibility necessary to accommodate the planning needs of the State of Nevada and Nevada's counties. We appreciate continued engagement on this issue even if a listing becomes necessary.

## Telecommunications

**Boosting Broadband and Emerging Technologies:** NACO supports the deployment and availability of emerging technologies, such as small cell 5G to all areas of Nevada, to ensure equitable economic and educational opportunities, as well as emergency preparedness. The Bipartisan Infrastructure Law also known as the Infrastructure Investment and Jobs Act provided \$42.45 Billion to funding broadband deployment in underserved areas. County officials must also fulfill their responsibilities as trustees of public property and as protectors of public safety and health during this deployment process. By preserving local authority, county governments can ensure that communications providers are serving the public interest regardless of the delivery platform. Federal policymakers should also support local decision-making and accountability and oppose any actions that would preempt or limit the zoning and siting authority of local governments.

NACO continues to be grateful for Federal investment in broadband expansion and access, especially in rural areas of the Silver State. The Infrastructure Investment and Jobs Act (IIJA)/<u>H.R. 3684</u>, created the Broadband Equity, Access, and Deployment (BEAD) program to provide federal funding to all fifty states for broadband planning, deployment, mapping, equity, and adoption activities. Widespread access to broadband is significant for advancements in education, economic development and health care delivery.

NACO has been a longtime supporter in calling for accurate broadband connectivity data which is essential to buildout critical broadband infrastructure in areas lacking access to high-speed internet. As companies continue to look to business-friendly states such as Nevada and as our counties continue to look to diversify their economies, it is essential that Nevada's counties have the connectivity businesses require. NACO is pleased that Congress and federal agencies afforded counties the opportunity to participate in the Broadband Data Collection (BDC) process, which was intended to be instrumental in the distribution of more than \$40 billion in federal broadband grants to states in 2023. The National Broadband Map consists of 2 datasets, each designed to be challenged as a means to continually identify the unserved and underserved communities most in need of funding for high-speed internet infrastructure investments. This is part of an ongoing effort to publish a new national map of broadband availability across the country to provide both fixed service and mobile service data.

**Cybersecurity:** Counties continue to face increasing risk of cyber threats from multiple sources every day and must ensure that citizens' personal information and critical infrastructure are protected, recoverable and secured in the event of any potential breach. NACO supports the State and Local Cybersecurity Grant Program (SLCGP), which is funded by the Bipartisan Infrastructure Law (BIL). The SLGCP provides a total of \$1 billion in funding over the next four years, to support state and local efforts to address cyber risks to their information systems.

## **County Financing and Funding**

**Optimizing Intergovernmental Partnerships and Federalism:** NACO is pleased with our partnership with our federal delegation, and we look to continued coordination on policies that benefit and impact Nevadans. NACO continues to oppose unfunded mandates and federal initiatives that fail to protect county revenue. We support efforts that recognize and respect the unique roles and responsibilities of counties as essential partners in our nation's intergovernmental system of federal, state, local and tribal officials. County governments are tasked with implementing both state and federal policies as well as regulations at the local level and should be included in all stages of the governing process. NACO urges Congress to support measures that increase transparency, reduce regulatory burden, foster intergovernmental dialogue, and unite all levels of government in supporting our unparalleled system of federalism.

**Support Funding for the Community Development Block Grant (CDBG) Program:** NACO strongly supports the Community Development Block Grant (CDBG) program established in the Housing and Community Development Act of 1974. The State of Nevada is a recipient of the State Administered CDBG program, also known as the Small Cities' CDBG program or the CDBG non-entitlement. Each State develops annual funding priorities and criteria for selecting projects. Nevada's priorities are established by the consolidated planning process, state priorities, and the regional community and economic development needs of each community. The CDBG program provides increased opportunities for elected county officials to plan, implement, and evaluate local community development and housing assistance programs.

## Transportation

Long-term Transportation Funding and Financing: NACO is pleased to see the passage of the five-year, \$973 billion Bipartisan Infrastructure Law (BIL), formally known as the Infrastructure Investment and Jobs Act (P.L. 117-58). The BIL directs \$284 billion toward modernizing and making improvements across all modes of transportation, with the majority of funding reserved for highways, roads and bridges. NACo created an interactive funding matrix that includes funding levels, program descriptions, and eligibility requirements that is continually updated and easy to interpret. Nevada will see additional federal funding that invests in our roads, broadband, wastewater systems and other critical infrastructure projects. Nevada's Counties support efforts by the administration and Congress to increase our nation's infrastructure investments to help promote economic development, public safety, and overall mobility. In Nevada, counties maintain over 75% of the roads in the State. Counties should be recognized as major owners of transportation infrastructure in any comprehensive package presented by the administration and Congress, including future surface transportation reauthorization legislation. All federal infrastructure investment should reflect county priorities, such as: allocating more federal seed capital and

matching funds for locally owned infrastructure, increasing local decision-making authority and flexibility, and streamlining and shortening the federal permitting process while still requiring robust public participation and world-class environmental stewardship. Additionally, the long-term solvency of the Highway Trust Fund is critical as is the Federal Lands Access Program (FLAP) funding.

## **Election Integrity & Funding**

Administering our Nation's Elections: NACO supports federal policies that provide flexibility for local decision making and increased federal investments in the nation's elections system. Election integrity and safety is critical to a strong democracy. As administrators and financers of our elections, NACO continues to support a consistent, predictable, and dedicated federal funding stream to assist counties with meeting the significant federal requirements already imposed on local governments administering elections. We also support efforts by Congress and the Administration to combat cybersecurity threats in a way that is inclusive of county election and technology officials. As Congress considers additional changes to our elections systems, NACO urges federal lawmakers to protect local control over election administration and oppose mandates and specific requirements regarding equipment, procedures, and personnel responsibilities.

# A YEAR IN REVIEW - 2023

## Nevada's Counties - United & Unique

Nevada's Counties entered 2023 with a robust local government-focused legislative agenda. NACO staff navigated a Legislature with a different look, nearly 16 Freshman legislators having just been elected and Nevada seeing a new Governor, following the election of former Clark County Sheriff Joe Lombardo.

The Nevada League of Cities and NACO spearheaded a partnership with UNR to provide a two-day newly elected official training program. Further, with the passage of AB 1 in the 2021 session, NACO provided new legislators an overview of "Why Counties Matter", including information on local services, providing resources to legislators and insight on fiscal matters, given the impact state policy makers have on local government. This training was well received and assisted our advocacy efforts throughout the session on issues relating to local government.

NACO's legislative work did not begin on day one of the legislative session, we engaged legislators, shared the county story and made ourselves a resource to policy makers on county related issues leading up to the first day of the 82nd Legislative Session. Ultimately, a majority of NACO's five sponsored bills passed the legislature and were signed by the Governor.

The session kicked off with NACO, Washoe and Clark Counties providing well received presentations to both the Senate and Assembly Government Affairs Committees and as we navigated the 120-day legislative session, worked to beat back proposed changes to county fiscal and administrative authority. This year, county governments were more united in our approach to policy making which did not go unnoticed by Legislators.

NACO continues to support and provide resources to our 100% county membership, undertaking a statewide, community driven public healthcare workforce study. We continue to provide interim support on Indigent defense, county funding, emergency response, land use and effective planning of the expenditure of opioid settlement dollars.

County commissioners, staff and our private sector partners across the state gathered in beautiful Elko County for the 2023 NACO Annual Conference. All told, nearly 300 individuals attended the 3-day event, hearing from experts on panels discussing public health, coordinating emergency response, broadband deployment, local tax abatements, economic development, workforce development, public lands, and a wrap up of the Legislative session. NACO honored Lincoln County Commissioner Varlin Higbee as our outgoing President for 2023.

NACO staff continue to do annual visits to counties to share NACO programs and advocacy. NACO is proud of the collaboration, leadership, and accomplishments of our member counties in 2023. We are looking forward to celebrating our 100-year anniversary of this esteemed organization in 2024, with an eye on the future and preparing ourselves for the next 100 years.

### Senate Bill No. 118–Committee on Health and Human Services

### CHAPTER.....

AN ACT relating to public health; authorizing the creation of a health district by certain counties which are not physically adjacent; making an appropriation; and providing other matters properly relating thereto.

### Legislative Counsel's Digest:

Existing law creates a health district in any county whose population is 700,000 or more (currently Clark County), which has jurisdiction over all public health matters in the health district. (NRS 439.361, 439.362, 439.366) Existing law authorizes the creation of a health district with similar jurisdiction in counties whose population is less than 700,000 (currently all counties other than Clark County), subject to approval by the State Board of Health, by affirmative vote of: (1) the boards of county commissioners of two or more adjacent counties; (2) the governing bodies of two or more cities or towns within any county; or (3) the board of county commissioners and the governing bodies of any incorporated city or cities, town or towns, in such a county. (NRS 439.370) **Sections 7 and 8** of this bill remove the requirement that two counties must be physically adjacent in order to create a health district.

Section 9.2 of this bill makes an appropriation to the Division of Public and Behavioral Health of the Department of Health and Human Services for allocation to specified entities for the improvement of public health. Section 9.2 requires each such entity to submit a report to the Interim Finance Committee at the end of Fiscal Year 2024-2025 and Fiscal Year 2025-2026, respectively, concerning the use of the allocated money.

# THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Sections 1-6.** (Deleted by amendment.)

Sec. 7. NRS 439.370 is hereby amended to read as follows:

439.370 By affirmative vote of:

1. The boards of county commissioners of two or more [adjacent] counties;

2. The governing bodies of two or more cities or towns within any county; or

3. The board of county commissioners and the governing body or bodies of any incorporated city or cities, town or towns, in such county,

 $\rightarrow$  and with the approval of the State Board of Health, there may be created a health district with a health department consisting of a district health officer and a district board of health.



**Sec. 8.** NRS 439.383 is hereby amended to read as follows:

439.383 When two or more **[adjacent]** counties establish a district board of health, all county boards of health in such district shall thereupon be abolished.

Secs. 8.5 and 9. (Deleted by amendment.)

**Sec. 9.2.** 1. There is hereby appropriated from the State General Fund to the Division of Public and Behavioral Health of the Department of Health and Human Services the sum of \$15,000,000 for allocation pursuant to subsection 2 for the improvement of the public health.

2. On or before August 1, 2024, the Division of Public and Behavioral Health shall allocate the money appropriated by subsection 1 to the following entities based on the following prescribed percentages of the total appropriated money:

(a) The Central Nevada Health District, 1.3 percent;

(b) The Washoe County Health District, 16 percent;

(c) The Southern Nevada Health District, 73 percent; and

(d) The Division of Public and Behavioral Health or a designee of the Division, 9.7 percent.

3. An entity to which money is allocated pursuant to subsection 2 shall:

(a) Evaluate the public health needs of residents of the area under the jurisdiction of the entity;

(b) Determine the level of priority of the public health needs identified pursuant to paragraph (a);

(c) Expend the allocated money in accordance with the levels of priority identified pursuant to paragraph (b); and

(d) Not later than 90 days after the end of Fiscal Year 2024-2025 and 2025-2026, respectively:

(1) Prepare a report which must include, without limitation:

(I) A description of the process used by the entity pursuant to paragraph (a) to evaluate the public health needs of residents of the area under the jurisdiction of the entity and the public health needs identified through that process;

(II) A description of the process used by the entity pursuant to paragraph (b) to determine the level of priority of the public health needs identified pursuant to paragraph (a) and the levels of priority assigned to those public health needs through that process;

(III) A description of each expenditure of the allocated money made by the entity pursuant to paragraph (c); and

(IV) The unexpended balance of the allocated money at the end of the fiscal year.



(2) Submit the report to the Director of the Legislative Counsel Bureau for transmittal to the Interim Finance Committee.

4. An entity to which money is allocated pursuant to subsection 2 shall not use the money to replace or supplant money available from other sources.

5. The portion of any money remaining at the end of Fiscal Year 2024-2025 from an allocation of the money appropriated by subsection 1 that is not committed for expenditure by June 30, 2025, must be carried forward to Fiscal Year 2025-2026 to be used for the same purpose. Any remaining balance of the allocated money carried forward to Fiscal Year 2025-2026 must not be committed for expenditure after June 30, 2026, and must be reverted to the State General Fund on or before September 18, 2026.

Sec. 9.5. (Deleted by amendment.)

**Sec. 10.** 1. This section and sections 1 to 9, inclusive, and 9.5 of this act become effective upon passage and approval.

2. Section 9.2 of this act becomes effective on July 1, 2024.

### SB118 - Public Health Infrastructure and Funding

SB118 amended state law to allow non-adjacent counties to form health districts (*such as the newly-created Central Nevada Health District*) and provided a \$15,000,000 allocation from the State General Fund for the improvement of public health.

The Division of Public and Behavioral Health (DPBH) is the health jurisdiction for counties not in a health district. For counties under this model, DPBH is partnering with County Health Officers and local governments to determine local public health needs and priorities. DPBH will disburse funds through grant agreements on July 1, 2024, and/or, as requested by counties, DPBH can utilize the funds to enhance/expand their local delivery of a current program.

Under the provisions of SB118, the following is required of health jurisdictions to determine spending:

- Conduct an evaluation of public health needs
- Prioritize public health needs based on evaluation
- Expend funds based on priority
- Report back on use of funds
- No replacing or supplanting already available public health funding

Previously conducted local Community Health Needs Assessments can be used to determine priority areas. Additionally, NACO/UNR Extension's Foundational Public Health Services Assessment (ongoing) can be used as the evaluation and prioritization process for each county as desired.
